This form is completed by the applicant only when specifically requested by a passport agency/center when sufficient evidence of entitlement is needed to process your application for a U.S. passport. The applicant has the option to complete the hardcopy form enclosed with the letter from the passport agency/center or complete a fillable PDF version of the form available from a link as provided in the written request. **Please Note:** You must print out the form and submit a hardcopy through the mail to the passport agency/center. You may not submit this form electronically. In addition to completing this form, you may be asked to provide further documentary evidence to support your citizenship claim. Documentary evidence should contain your full name, date and/or place of birth, the seal or other certification of the issuing official. IMPORTANT

- 4. If you don't know the answer to a question, please write "I don't know." If you believe a particular question does not apply to you or your circumstances, please write "Not Applicable" or "N/A." The Department realizes that most information for this questionnaire may be difficult to obtain and will likely come from other sources. The Department will take these factors into account in the passport issuance process.
